This past year was certainly a year of challenge for many of us, including PILS as an organisation. My presidential term was the first – and hopefully the last – term of exclusively online activities for PILS due to the ongoing COVID-19 pandemic. Nevertheless, even a global pandemic did not crush our spirit as an organisation.

PILS has not only adapted, but also thrived under these challenging times. This past year we have conducted more workshops and webinars than ever before, working together with PILS' Alumni, the Asian International Arbitration Centre (AIAC), the Indonesian Society of International Law (ISIL), Hendra Soenardi Law Firm, and other mooting societies from Universitas Udayana, Universitas Indonesia, and Universitas Padjadjaran. We have also launched an official website, the first among all student organisations in FH UNPAR, to increase our online presence and act as a centralised platform for all past and future achievements of PILS.

Moreover, despite the pandemic, PILS' mooting teams have truly excelled on a global level. This year's Vis Team advanced to the Quarterfinals of the Vis East Moot out of 147 teams. This is a historic achievement, as no Indonesian team has ever reached higher than the Quarterfinals. PILS has achieved this only in our fifth year competing in Vis.

Adding to our list of note-worthy awards is the Jessup Team, who achieved the 2nd Best Memorials in the Asia Pacific Regional Rounds of the 2021 Philip C. Jessup International Moot Court Competition. Most remarkably, the Jessup team achieved the Hardy C. Dillard Award for 17th Best Combined Memorials in the Global Rounds of the Jessup (from more than 570 law schools participating). This marks the second time UNPAR has achieved the Dillard Award, the first time being in 2008. This Yearbook will chronicle and summarise PILS activities and achievements over the last year.

Finally, I would like to use this opportunity to express my deepest gratitude to everyone involved in all of PILS' activities. The involvement and cooperation from everyone including PILS' members, interns, advisors, faculty members, and alumni is the main reason that PILS have been, still is, and always will be an organisation geared for nothing but success. Thank you, and farewell.

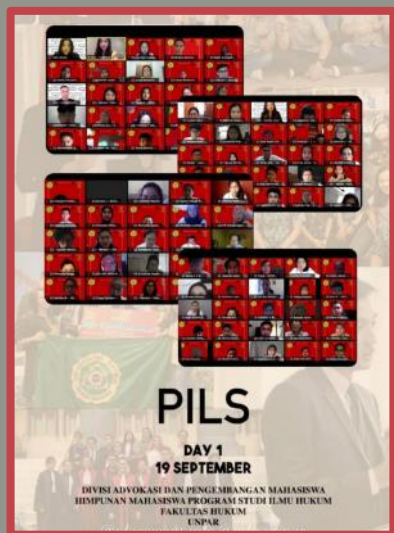
